Please complete the most updated Architectural Barriers Project Registration form. New Forms may be obtained by calling Jason R. Brumley.

One complete set of construction documents must be submitted for review within (20) twenty days of issuing to owner, (drawings and specifications for all disciplines) signed, sealed, & dated by the design professional with the overall responsibility for the project (Architect, Engineer, Interior Designer, or Landscape Architect).

A check made payable to **HYI UGF5 G**, covering the appropriate fees. The \$175.00 required TDLR Filing Fee must be paid upfront along with the Plans Review Fees. Inspection Fees may be submitted with Plans Review Fees. Please allow 7-10 working days for a review to be completed.

**For Inspections**

A check made payable to **HYI UGF5 G** covering the appropriate Inspection Fees.

Please Note: An Inspection request is required no later than 30 days after construction completion date.

**Special (Preliminary) Inspections**

Please contact Mr. Jason R. Brumley A minimum of (5) working days prior to special inspections date being requested to allow for scheduling.

Note: Although not required by law, special inspections are HIGHLY recommended prior to substantial completion of construction.

Responsibility for compliance with Article 9102 of the Texas Civil Statutes is placed upon the design professional with overall responsibility for a project, and/or the Owner of a facility. Plans Review shall not be construed as acceptance of responsibility for such compliance by Jason R. Brumley and/or his affiliated company(s).
